If our roof tiles verifiably fail to comply with these requirements during the warranty period and cannot perform their required function, we provide replacement ex-works free of charge for all roof tiles which do not comply with DIN EN 1304 and have become verifiably dysfunctional due to frost.

During the period of five years from the date of delivery, we furthermore take over the roofing costs for the replacement of the roof tiles which do not comply with DIN EN 1304 and have become dysfunctional due to frost. We reserve the right to perform the work ourselves or have the work executed by a company commissioned by us.

2. The warranty excludes damages created by mechanical defects, extraordinary weather conditions, gale winds and/or cases of force majeure as well as roof tiles which can be reused at a different location.
